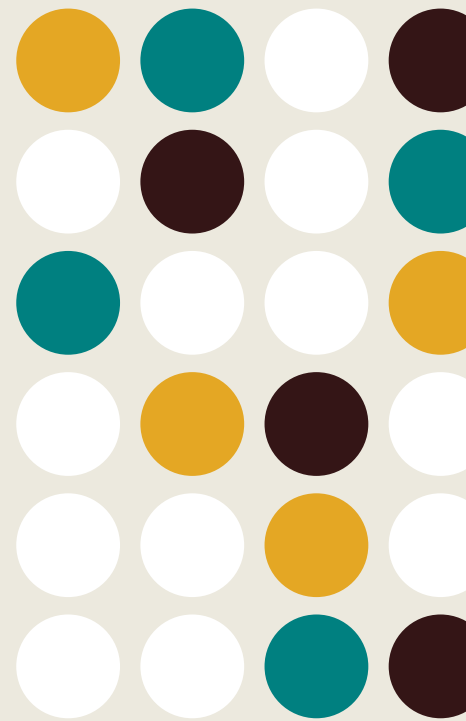

On January 9, 2024, CMS approved New York State's section 1115 Waiver Amendment Request of \$6.7B in funding to improve the health of New Yorkers. The Medicaid Redesign program will award up to **13 social care network (SCN) lead entities**.

STEP 1: **Complete A Member Eligibility Check**

Search within the verified Medicaid members to find an individual, confirm they are a current member.



STEP 5: **Glean Insights from your Social Care Network Dashboard**

Review activity and referral statuses and assign next steps via your Social Care Network (SCN) dashboard in your Findhelp platform analytics.



STEP 2: **Complete a Social Needs Assessment**

Complete the designated New York Medicaid Redesign Team assessment on the Findhelp platform on behalf of the members you're serving.



STEP 6: **Generate a Claims Form**

CBOs will generate real claims files with New York services and the mapped social care codes.



STEP 3: **Map Social Care Codes To Your Assessments**

Reporting codes are mapped to your assessment questions and responses to support State requirements



STEP 7: **Submit Your Claims for Reimbursement**

CBOs will submit the generated claims to the SCN who will share them with the partner payer for reimbursement.



STEP 4: **Send The Assessment Data To Your Partner Hie**

Share the completed assessment data via bidirectional integration with your local partner HIE.



STEP 8: **Receive And Distribute Payments From The Partner Payer**

Based on the submitted claims, the partner payer will reimburse the SCN to pass along to the community organization who provided the services.
